

SGCH and Lighthouse Infrastructure unveil innovative funding model for key worker housing

SGCH is pleased to announce that we are partnering with specialist infrastructure investment manager, Lighthouse Infrastructure ("Lighthouse") to acquire key worker housing.

In this landmark deal, Lighthouse provided \$59M initial funding to SGCH Keys, a registered charity and subsidiary of SGCH Group. The funds have acquired 85 apartments in Westmead for key and essential workers.

SGCH has brought together capital and capability to assist key workers who are struggling to find housing they can afford in Sydney. It is hoped that a number of the key workers who will call these properties home will be able to take advantage of rent savings over time to springboard to own a home of their own in the future. The 85 properties purchased are valued at \$59M and are within the Highline development completed this year by leading Sydney developer and builder, Deicorp. Highline is located just 500m from Westmead Hospital and 100m from Western Sydney University campus. The tenancies will be managed by SGCH, with key worker tenants meeting the criteria of low to moderate income bands, and working in designated sectors such as emergency services, health and education.

Speaking about the new partnership, Scott Langford, CEO of SGCH commented, "SGCH has the proven capability, expertise, and vision to partner with capital partners who have the appetite to be a part of a structural shift in the way that community housing is funded. This partnership with Lighthouse is an alignment of purpose that delivers scalable housing solutions for key workers."

Modern Slavery Statement 2021

Further cementing the growth and maturity of one of Australia's leading community housing providers, SGCH has published its first Modern Slavery Statement.

The Modern Slavery Act 2018 (Cth) requires organisations with an annual consolidated revenue of more than AUD100 million to identify and report on the risks of modern slavery in their operations and supply chains, and the steps taken to address, assess and manage these risks.

Group CEO Scott Langford says "As a not-for-profit organisation focused on improving lives we are opposed to all forms of modern slavery and recognise our responsibility to be transparent in how we identify and address risk.

"As we increasingly grow our impact as an organisation we are committed to meeting the expectations of our customers and stakeholders to ensure we understand and develop our approach to addressing modern slavery risks. This is a continuation of our embedded focus on governance, impact and our operating culture."

The statement outlines the organisations structure, operations, supply chains and risks. It examines the actions in place and their effectiveness in addressing risk and outlines a strategy to continuously improve in partnership with stakeholders and our supply chain.

Bianca's Story

When you first speak to new Gibbons Street customer, Bianca, you can't help but be filled with optimism and positivity. Her honesty and obvious gratitude give no indication of the trauma and challenges she faced before finding her new home.

Bianca was born to drug addicted parents and by the age of five, was placed in a children's home through DOCS.

Whilst in the children's home, her father passed away and her mother got clean. Bianca was also subjected to what she describes as "unspeakable acts of abuse" whilst living in the home.

"When my Mum got clean, I moved back in with her and she tried her best. But at that stage I hadn't disclosed my abuse. I couldn't regulate my emotions and my behaviour was out of control. Mum put me in a school for kids with behavioural issues, but in the end, I was just too much for her. She stayed clean but I ran away from home when I was 11."

The years that followed saw Bianca living on the streets of Kings Cross. She developed a substance abuse problem and from the time she was 18, she was in and out of custody for minor offences including drug charges and prostitution.

"When I was 34, my addiction was so out of control, I committed a violent offence. It was provoked but there is no excuse. I was charged and convicted of attempted murder and sentence to 13 years in custody", said Bianca.

Whilst in custody, Bianca was able to get clean and has been ever since. She served her full sentence and found herself a free woman in March 2021 but with nowhere to live.

"I eventually found a friend in Liverpool and began my parole there. I went to the housing department but because I was out of area, no services could help me. The friend I was living with was actually using

drugs. I wanted to stay clean so without much other choice, I left and moved back to Sydney City."

Bianca was put up in a hotel for a few weeks at Samaritan House in Central and things slowly began to fall into place.

"Civic and Salvos heard my story. I wasn't on a Disability pension at that stage or NDIS but I began the process. Everything was approved around the same time. It was a gruelling four months, reliving my trauma and having to retell my story over and over", she shared.

"When I was told I was approved for housing I felt the same way I did when I was released from custody. My biggest gratitude is being able to see the night sky, I love the view from the 13th floor. I have a secure home and I am five minutes from my grandmother. Plus, the staff are amazing."

Now that she's moving in, Bianca is taking some time to breathe and work out what comes next for her.

"It has been a really difficult journey but I am happy to be here. I fought really hard to get here. I plan to use my NDIS plan and decide what I need most" she said.

Bianca is also looking forward to reconnecting with her Mum, who is currently overseas.

"Soon I will have a hug from Mum for the first time in 5 years, the one thing that's really missing. In the meantime, I have a foundation. To me that's forever. It is central to everything. I couldn't have asked for a better location and a better home."

New Social Housing Coordination Plan

SGCH, Link Wentworth and Bridge Housing in partnership with Women's Housing Company are proud to announce the release of the Northern Sydney Social Housing Service System Coordination Plan for 2021-2024.

This is the second three-year rolling plan, which sets out our collective approach and key priorities for managing the social housing system in Northern Sydney. The 2021-2024 plan also builds on the achievements and learnings of our work since 2018, when the Department of Communities and Justice transferred management of 4,500 public housing tenancies to these four providers across the Northern Sydney District.
